Condition of the sale of a Siberian Moon kitten is as follows:

1. Buyer accepts the responsibility for the care and welfare of this kitten/cat for the lifetime of the animal. This kitten /cat will not be allowed outdoors unsupervised to ensure it's health and safety. This animal will receive regular vet visits and will be given top quality medical care.

2. Buyer agrees never to declaw this kitten/cat, unless approval is granted in writing by breeder, and understands that declawing is a mutilation and cruelty that is likely to alter the kitten's/cat's temperament and health.

3. Buyer agrees that if any of the terms of this agreement are violated, breeder may reclaim this kitten without refund of purchase price. If this contract is litigated, any suit shall be filed and tried in Massachusetts under the law of Massachusetts. The buyer in any litigation would pay for the court costs and the legal expenses incurred by any action filed against Siberian Moon Cattery or its owners.

4. In the event that the buyer becomes unable to continue to provide a suitable home for the cat, Siberian Moon will assist the owner in finding a new home for said cat.

5. Pets must be altered by 6 months of age or puberty. This kitten cannot be used for breeding or Siberian Moon Cattery reserves the right to reclaim the cat and all offspring it has produced.

6. In the unlikely case of an allergic reaction, we will accept the return of a kitten within the first 7 days from the date of sale with a full refund less \$450. Siberian Moon Cattery guarantees kittens for genetic defects for 2 years if that said defect is evidenced in an autopsy report. Siberian Moon will replace that kitten when you are ready. Siberian Moon is not responsible for vet bills incurred. NO CASH REFUNDS WILL BE GRANTED.
